The employees of the National Thermal Power Corporation (NTPC) gave up their one day's wage for the cause, contributing a total of 73 crore. NTPC has also deployed a helicopter for the rescue operations and has shown willingness to the Union minister of power to set up a relief project worth 10 crore. "NTPC stands by the people of Uttarakhand and extends whole hearted support to them. As a responsible corporate citizen NTPC extended modest contributions in the hour of crisis," said Arup Roy Choudhury, chairman and MD, NTPC.

Coal India has contributed ₹50 crore from its current year's CSR budget to the chief minister's relief fund. The employees of Western Coalfields, which comprises of five Central Trade Unions and Coal Mines Officers' Association have contributed their one day's salary which is about ₹5 crore for the cause. Bharat Coking Coal has made donations worth ₹20 Coar to the CM's Relief Fund. Mahanadi Coalfields and Western Coalfields have also contributed ₹5 crore to the PM's Relief Fund.

The Airport Authority of India is working with the Uttarakhand government to reconstruct the destroyed infrastructure. The employees of Gas Authority of India Limited (GAIL), the Food Corporation of India (FCI) and RSN, have chipped in by contributing their one day's salary for the

flood victims. FCI has also increased the percentage of wheat allocation to the state. Public sector banks including State Bank of India (₹2 crore) and Bank of India (₹1.5 crore) have also helped in the rehabilitation process. Indian Oil has provided logisti-

Indian Oil has provided logistical support in addition to contributing ₹2 crore. Hind Copper has donated ₹2 crore. ONGC, BHEL and Bharat Petroleum have also donated ₹1 crore each.

Private sector aid: Amongst the private-sector companies, Sir Ratan Tata Trust and Navajbhai Ratan Tata Trust have deployed three camps. On a short term basis, the Trust has provided 5,000 water purification plants, 5,000 solar lanterns, truckmounted reverse-osmosis units, prefabricated tents, blankets and food packets. On a medium term basis, the Trust has been involved in rebuilding residential homes.

residential homes. The Confederation of Indian Industries has sent rescue teams to Rudraprayag and Chamoli districts of Uttarakhand. They have also provided temporary shelters, water purifiers, solar lanterns, torches, blankets, and warm clothing for the survivors. ITC, Nestle, and Britannia have

ITC, Nestle, and Britannia have sent food and relief material. HCC is participating in the relief work by helping in clearing debris off the road. DLF has contributed ₹50 lakh for the relief work.
